
HOUSE RULES GENERAL VISITING CONDITIONS**PURPOSE OF THE HOUSE RULES**

The purpose of these House Rules is to define the general terms and conditions of use and rules:

- which have a fundamental importance to persons using the services of the HUNGARORING facilities and persons involved in the operation and utilization.
- and which contribute to the proper, safe, and efficient operation and functioning of HUNGARORING.

USE OF THE HOUSE RULES

By purchasing a ticket and entering into HUNGARORING premises, users accept the rules of the House Rules as binding upon themselves.

Users also acknowledge and accept that the organization of events in the outdoor areas of HUNGARORING may be affected by weather and natural conditions, and they enter into the territory with this knowledge.

The Operator shall ensure that the House Rules are available on the HUNGARORING premises and on the website www.hungaroring.hu.

The House Rules shall be applied to all services provided by the Operator and its contractual partners and all events held on the territory of HUNGARORING (hereinafter referred to as Events), unless the organizer, right holder, or service provider of the Event requires additional special rules, in which case the aforementioned parties are obliged to inform Users separately.

The Operator shall be entitled to amend the provisions of the House Rules by unilateral declaration, in particular, but not exclusively, if changes in the relevant legal and regulatory requirements make this necessary or mandatory.

SCOPE OF THE HOUSE RULES**TEMPORARY EFFECT**

The House Rules are made by the Operator for an indefinite period of time in order to promote and achieve the above objectives, in compliance with the applicable legal and regulatory requirements.

TERRITORIAL SCOPE

The territorial scope of the House Rules covers the entire operating area of HUNGARORING, including the parking lot located in front of the Main entrance outside the HUNGARORING.

HUNGARORING operating areas:

- Main entrance parking lot
- Office building
- Café
- Service and access roads, internal parking lots
- Circuit
- Pit lane
- Pit
- Main building and Paddock
- Event area
- Grandstands
- Driving Center building
- Driving Center training tracks
- Off-road track and inner wooded area
- Go-kart track

PERSONAL SCOPE

Compliance with the provisions of the House Rules is mandatory for all persons present on the territory of HUNGARORING.

- **Employee:** a person employed by the Operator on the HUNGARORING territory on an occasional or regular basis – on the basis of an employment contract, service contract or other legal relationship – acting on behalf of the Operator and in his interests. This includes persons who are independent of the Operator and provide services on the territory of HUNGARORING, as well as persons employed on an occasional or regular basis by persons using the territory on the basis of a contractual relationship – on the basis of an employment contract, service contract or other legal relationship – acting on their behalf and in their interests.
- **Visitor:** a natural person participating in the Event on an occasional basis and on the basis of a general admission ticket or other type of accreditation.
- **Users:** the collective term for Employees and Visitors who are present on the HUNGARORING area or use the services provided at HUNGARORING.

Persons under the age of 18 may only enter the territory of HUNGARORING if accompanied by an adult!

GENERAL VISITING CONDITIONS

Visitors entering the territory of the HUNGARORING are required to comply with the instructions of security personnel, sport professional staff, and Employees. The Operator reserves the right to refuse entry and participation in the event to persons who do not meet the entry requirements set out in these House Rules or who pose a safety risk to themselves or others.

During events at HUNGARORING, users may be exposed to increased noise levels. We recommend the use of hearing protection during races and other loud events.

Participants in programs and events shall use the HUNGARORING territory and facilities at their own risk.

While on the territory of HUNGARORING, please take care to protect the physical safety and health of others.

Adults accompanying persons under the age of 18 entering HUNGARORING are responsible for such minors. It is the responsibility of the accompanying adult to ensure that persons under the age of 18 understand and comply with the House Rules.

During events, unauthorized persons are not permitted to enter areas closed off to visitors, in particular pit lane, pits, and paddock buildings. Access for work purposes is only permitted with the prior consent of the Operator. It is also prohibited to climb over fences, open locked doors and/or cross other barriers or closures.

The HUNGARORING area is monitored and guarded 24 hours a day by security personnel using CCTV, which is recorded in compliance with the relevant data protection laws.

Photography, audio and video recording may take place on the HUNGARORING territory. By entering and staying on the territory of HUNGARORING, every person (or, in the case of minors or persons with limited legal capacity, their parents or guardians) consents and gives permission to the Operator to photograph, film, record video, or otherwise reproduce their image, portrait, and/or voice and to use them for any purpose, including on websites, social media, in news reports, and in advertisements, without payment and on a permanent basis. The User acknowledges that all photography, filming, and/or recording is done on the basis of this consent. If you do not agree with the above, please do not enter the event venue or contact the Operator. Information on data processing in connection with the taking of photos and videos is available on the website www.hungaroring.hu.

The Operator reserves the right to make the taking of photographs and videos on the territory of HUNGARORING subject to its prior consent.

The Circuit may only be used with the prior permission of the Operator, after signing a contract or written liability declaration, and in compliance with the rules prescribed by the Operator. The Circuit is one-way, so reversing or turning around on it is strictly prohibited as it endangers your own and others' physical safety and health.

Banners, signs, and flags (including, but not limited to, vehicles, clothing, hats, or other accessories) brought into the HUNGARORING area must comply with the provisions of these House Rules and the laws in force at any given time.

Banners, signs, and flags may not contain obscene or discriminatory language, symbols, logos, or graphic representations. The Operator reserves the right to approve or prohibit the bringing of banners, signs, etc. into the area if their content or appearance violates these House Rules or the law.

With regard to the protection of minors and the laws in force in Hungary protecting them, the following applies to persons under the age of 18 on the territory of the Circuit:

- (a) products listed in Act CXXXIV of 2012 (1) (all types of tobacco and new types of tobacco products, as well as accessories related to their consumption) may not be sold or given as product samples;
- (b) alcoholic beverages and energy drinks with the composition specified in government decree may not be sold, given as product samples or served;
- (c) Participation in gambling is not permitted.

Based on the above, persons under the age of 18 are PROHIBITED from consuming the products listed in points (a) and (b) and from using the services listed in point (c).

The sale of food, beverages, souvenirs, and clothing, as well as the display and distribution of any type of advertising material on the territory of HUNGARORING, is subject to the prior and express permission of the Operator. It is prohibited to place advertisements or engage in advertising activities on the territory of HUNGARORING that violate the provisions of Act XLVIII of 2008 and Act CLV of 1997.

Persons under the influence of alcohol or other mind-altering substances may be removed from the territory of HUNGARORING.

Smoking is only permitted in designated areas and is strictly prohibited in other areas of the HUNGARORING.

The traffic rules (KRESZ) in force under Hungarian law shall be applied throughout the entire HUNGARORING area. All vehicles must comply with the 20 km/h speed limit on all service and traffic roads, as well as in the paddock areas.

Parking is only permitted in designated areas. Parking is prohibited on the Circuit and in the pit lane. The Operator may have unauthorized parked vehicles removed at the owner's expense.

Fireworks, bengal lights, ignition devices, sticks, rods, poles, parasols, glass bottles, stones, objects that can be used as cutting or stabbing weapons, and any weapons are prohibited on the territory of HUNGARORING. Security personnel are authorized to inspect bags and any storage containers and/or personal clothing and to confiscate the items listed above upon entry to the premises.

Without the prior permission of the Operator, it is prohibited to barbecue, operate an outdoor kitchen, or perform any activity involving the use of open flames on the premises of HUNGARORING.

The Operator shall not be liable for the theft, damage and/or loss of any tools, equipment or materials left or stored on the premises of HUNGARORING, nor for any personal items brought onto the premises of HUNGARORING or their possible loss.

The use of unmanned vehicles, drones, and other aircraft (whether remote-controlled or autonomous) is prohibited on the premises of HUNGARORING without the prior written permission of the Operator. Vehicles intended for racing may only be operated on the Circuit and in the areas designated for that purpose at the given event.

Electric vehicles (EVs) may only be charged using dedicated and designated chargers or power points in accordance with the rules of use.

Pets are NOT allowed on the HUNGARORING premises, with the exception of guide dogs. In special cases, the Operator may issue a special permit.

Waste must be disposed of in the designated waste bins on the HUNGARORING premises; it is prohibited to dispose of waste elsewhere. Persons entering the HUNGARORING premises are required to use the restrooms provided by the Operator or its partners on the HUNGARORING premises.

Noisy activities may only be carried out on the HUNGARORING premises between 9:00 a.m. and 6:00 p.m. Outside the specified hours, activities involving noise emissions are only permitted with the written permission of the Operator. Between 10:00 p.m. and 6:00 a.m. (nighttime quiet hours), activities involving noise emissions are prohibited.

Technical work may only be carried out on the HUNGARORING premises with the prior written permission of the Operator. It is prohibited to alter the original condition of any building/area, with particular regard to the affixing of stickers, advertising materials, painting, drilling, and structural changes. During technical work carried out with the Operator's permission, cleanliness must be ensured and environmental pollution must be avoided. This includes, but is not limited to, the proper storage and disposal of liquids, debris, and waste. Any spilled material must be cleaned up immediately to ensure a safe and clean working environment. It is strictly prohibited to remove hazardous waste (in particular, but not exclusively: used tires, car parts, fuel cans, etc.) from the HUNGARORING premises. It is prohibited to lay cables and hoses on the HUNGARORING premises without the operator's permission.

It is prohibited to carry out work that causes environmental pollution anywhere on the HUNGARORING premises. In particular, but not exclusively, it is prohibited to repair vehicles in the spectator areas or parking lots. Vehicles may only be repaired in the paddock if it is ensured that any fluid leaks do not cause environmental pollution or noise pollution (in particular, they must not disturb the night-time quiet period).

Our staff will monitor compliance with and enforcement of the above rules.

ANY BREACH OF THE HOUSE RULES SHALL, FOLLOWING THE FIRST VERBAL WARNING, RESULT IN EXPULSION FROM THE PREMISES OF THE HUNGARORING.

THE UNAUTHORIZED USE OF THE CIRCUIT IS STRICTLY PROHIBITED AND EXTREMELY DANGEROUS, AND SHALL RESULT IN EXPULSION FROM THE PREMISES OF THE HUNGARORING AS WELL AS THE OBLIGATION TO PAY A USAGE FEE.

We draw your attention to the specific dangers associated with car and motor sports, the dangers arising from the behavior and/or possible mistakes of competitors, and the dangers arising from the mistakes of other visitors. All persons entering the HUNGARORING premises must be aware that:
