

TERMS AND CONDITIONS OF SALE RELATING TO ADMISSION TICKETS TO THE FORMULA 1 PIRELLI GRAN PREMIO D'ITALIA 2025

DEFINITIONS

1. In this document:

a) Event shall mean the FORMULA 1 PIRELLI GRAN PREMIO D'ITALIA 2025;

b) Country of the Event shall mean ITALY;

c) FIA shall mean the Fédération Internationale de l'Automobile or any employee, representative, agent or contractor acting on behalf of the FIA;

(d) FOWC shall mean Formula One World Championship Limited;

e) Promoter shall mean Automobile Club d'Italia - ACI, which entrusted ACI Sport S.p.A. with the management of all ticketing services referring to the Event;

f) ACI Sport S.p.A. or ACI Sport shall mean the company entrusted by ACI with the management of ticketing activities referring to the Event;

g) TicketOne S.p.A., with registered office in Via Fabio Filzi 29 - 20124 Milan (Italy), tel. +39-02-392261, fax +39-02-

3922670, shall mean the provider of the ticketing platform and of the ancillary and complementary services for the

issuance, distribution, collection and delivery of tickets related to the Event which acts, within the scope of the Sales

Agreement, in the name and on behalf of ACI Sport;

h) Terms and Conditions shall mean this document and any other document incorporated by reference;

i) Venue(s) or Event Venue shall mean Monza National Motor Racing Circuit, Viale di Vedano 5 - 20900 Monza (MB);

j) You, the Ticket Holder or User or Customer shall mean a person who has purchased or obtained a ticket for the Event,

or a person who otherwise uses or attempts to use a ticket.

GENERAL PROVISIONS

2. By purchasing, possessing and/or using (or attempting to use) a ticket to access the Event Venue, you signify your

acceptance of and agreement to comply with the following Terms and Conditions.

3. These Terms and Conditions are subject to any additional Event admission, security, public order and safety-related

conditions, terms or regulations that may be posted at the Venue or issued from time to time by the Promoter, available at

www.monzanet.it (the Venue Regulations). However, in the event of conflict between these Terms and Conditions and

the Venue Regulations, these Terms and Conditions shall prevail.

4. In case you purchase a ticket for a person under eighteen (18) years of age, you are responsible for ensuring that the

under-age complies with these Terms and Conditions and that a parent or guardian agrees to these Terms and Conditions

on behalf of the under-age.

5. In case you have purchased a ticket on behalf of another person, you must bring these Terms and Conditions to that person's attention.

6. The Tickets for the Event can be purchased on the official websites www.MonzaGPF1.ticketone.it (partnershop) and www.Ticketone.it, as well as at TicketOne and Promoter/ACI Sport's network of physical points of sale with the following

General Terms and Conditions of Purchase <https://www.ticketone.it/en/help/terms> or on authorized third-party sites, including www.formula1.com.

7. The Promoter and ACI Sport shall not be held accountable for the sale of tickets on websites other than official websites.

Therefore, they are not responsible for any problems that may arise if an order is placed by a customer on a website other than the official websites.

TICKET USAGE

8. You may be refused entry to the Venue in case you attempt to use or present a ticket purchased, acquired, or obtained from an unauthorized vendor.

9. Entry to the Venue will be granted only upon presentation of a valid ticket. Proof of identity or age may be required to

verify the ticket holder's right to use the ticket according to the relevant ticket type or classification.

10. Ticket Holders in possession of a child ticket or other reduced ticket category who are ineligible to hold such a ticket

may be denied entry to the Venue or required to pay the difference between the cost of the ticket held and the price of a full adult ticket.

11. The Promoter reserves the right to change the seat allocation (if any) without prior notice for any reason.

12. No admission or readmission is allowed after the end of each day of the Event.

13. You must keep your ticket safe and in good condition. The Promoter reserves the right not to replace or accept lost,

forgotten, stolen, damaged, spoiled, counterfeit or destroyed tickets or tickets that are illegible or incomplete. Promoter will

not replace tickets for seats classified as general access or unassigned.

REFUNDS, BAN ON TICKET RESALE AND TRANSFER

14. Tickets for the Event are strictly non-transferable and non-resaleable.

15. No Event tickets may be put for sale or offered for resale for any form of compensation or prize without the prior written

consent of the Promoter and of the FOWC and without compliance with these Terms and Conditions in all respects.

16. Before being obtained, no Event tickets may be used by any person for advertising, promotional or commercial

purposes including, without limitation, prizes, contests, lotteries or be included in hospitality packages or other products

without the prior written consent of FOWC and the Promoter.

17. Tickets are non-refundable except as stated in these Terms and Conditions or as required by law.

18. Any ticket offered for sale, sold or transferred in violation of these Terms and Conditions may be cancelled and any

person attempting to use such ticket may be refused entry or evicted from the Venue without refund or compensation.

19. Neither the Promoter, nor the FIA or FOWC guarantees that a session or day of the Event will take place on the date

and time indicated on the ticket. The Promoter, the FIA or FOWC may make changes to the date and time of a session or

day of the Event in the event of unforeseen circumstances, including adverse weather conditions or safety issues. No

refunds will be given if a session or day of the Event is delayed, interrupted, or not completed.

20. Unless required by law, refunds or ticket changes will be provided only if the Event is cancelled. If the Event is

cancelled, no booking and delivery fees nor the service fee charged by TicketOne will be refunded. In the event of

cancellation of the Event, Promoter will refund the ticket price to the person who purchased the ticket, via the same method

of payment used by that person that purchased the ticket. Except where required by law, no refund will be given with

respect to any taxes or fees paid in addition to the ticket price (e.g., any shipping, courier, transportation, or accommodation

costs) and no interest or costs will be borne by the Promoter for any amounts refunded.

21. No refund or ticket exchange will be given if you choose not to use your ticket or not to attend the Event.

VENUE CONDUCT

22. The Promoter reserves the right to refuse admission to the Venue (or remove from any Venue) any person (a) who

fails to comply with these Terms and Conditions; (b) who is not in possession of a valid ticket; (c) who is in possession of

a ticket sold or used otherwise than in accordance with these Terms and Conditions; and the Promoter further reserves

the right to refuse admission to the Event Venue for reasons of public health, safety, security, or maintenance of good

public order.

23. Safe and respectful behavior must be maintained while at the Venue. The Promoter reserves the right, for any reason,

to refuse admission and remove persons from the Venue, including cases where: (a) your behavior is likely to negatively

affect the enjoyment of others; (b) you are or your behavior is likely to cause a breach of the peace; (c) you appear to be

under the influence of alcohol or illegal substances; or (d) you fail to follow the instructions, including legal instructions, of

Event staff or security personnel.

24. You may be exposed to loud noises during the Event. You, all of your guests, especially children, are advised to wear

hearing protection devices during races, and live music events (if any).

25. You must follow the instructions given by Event or Venue staff, personal security and emergency services authorities,

and comply with all relevant laws and regulations of the Event Country.

26. You must not obstruct access routes, exits, entrances or stairways, or seek access to grandstands, seats or areas for

which you do not have a ticket.

27. No animals (except for registered service dogs) will be allowed in the Venue.

28. You shall not bring, use, distribute or display (free of charge or otherwise) within the Venue any sponsorship,

promotional or marketing material or do anything else that would lead a reasonable person to believe that you have a

sponsorship agreement with the Promoter, the Event or the FOWC or its affiliates.

SAFETY AND SECURITY

29. You must comply with all safety measures and instructions provided by the Promoter (or his authorized agents), by

any official, steward or staff member of the Venue.

30. The Promoter reserves the right to direct you to leave the Venue at any time for safety reasons.

31. The Promoter may use CCTV cameras at the Venue. Your image may be captured by these CCTV cameras. The

Promoter may share CCTV footage with law enforcement if necessary.

32. You must ensure that both you and your bags are available for inspection. The Promoter may refuse entry or exit from

the Venue to anyone who refuses to consent to such inspection.

33. You must not go to the Venue or seek entry into the Venue while in possession of: (a) bottles, cans, glass containers,

or food and beverages belonging to you (unless permitted under the Venue Regulations); (b) illegal substances or any

item that could be used or construed as a weapon and/or jeopardize public safety or the enjoyment of the Event, including

knives, bladed objects, fireworks, smoke grenades, personal protection sprays, air horns, vuvuzelas, whistles, flares,

firearms, ammunition, weapons, or dangerous objects; (c) drones or similar equipment, telephone jammers, radio

scanners, walkie-talkies, laser devices, selfie sticks; (d) bicycles, roller skates, skateboards, scooters, baby carriages; (e)

items that, in the Promoter's discretion, could be used to sabotage or damage property; or (f) items of a political, religious

or other similar nature or items bearing offensive slogans or messages (Prohibited Items).

34. Any person in possession of Prohibited Items may be refused entry or expelled from the Venue or may be allowed to

remain in the Venue only if such Prohibited Items are surrendered.

35. All Prohibited Items surrendered shall be considered as irrevocably and voluntarily surrendered. Such items may be

disposed of by the Promoter without liability.

IMAGES AND RECORDINGS

36. You shall not make, create, store, record or transmit any type of sound recording, visual or audiovisual footage (Recording), or store, record or transmit any information or other data, including times, results, official performance, telemetry, weather or race control data (Data) relating to, or in connection with the Event. It is prohibited to bring into the

Venue any equipment that would enable the abovementioned actions. Personal electronic devices (including still cameras,

cellphones, and other portable personal communication devices) are permitted inside the Venue, unless otherwise

specified, provided that recording, data, and any images, including photographic images and still images derived or that

may be derived from a recording (Image) of the Event that is recorded, stored, and/or created on it is used only for personal,

private, and non-commercial purposes.

37. As a condition of admission to the Venue, you agree that: (a) the use of such Recording, Data or Image for any form

of public advertising, display, commercial gain or for any other purpose (other than private enjoyment) without the prior

written consent of FOWC is strictly prohibited and will constitute a violation of these Terms and Conditions for which you

may be liable; and (b) upon the request of the Promoter or the FOWC, you shall assign in writing to the FOWC all copyright

and other intellectual property in any Image or Recording that you create, make, store or record, during or in connection

with the Event; and (c) you consent to the use by the FOWC (and any third party authorized by the FOWC from time to

time) for the purpose of or in connection with any publication, display or broadcast (including any advertising or promotional

material, campaign or materials) in any media throughout the world, in perpetuity and on a royalty-free basis, and approved

by the FOWC for any still or moving image of you taken at the Event, in which your Image, voice or likeness is featured,

you waive any and all of your personality and privacy rights to the extent necessary to permit such use.

38. Unauthorized Recordings, Images or similar objects or content may be seized and destroyed. The Promoter, the

FOWC (and its affiliates) and the FIA shall not be liable for any loss, theft or damage resulting from such confiscated or

destroyed items.

39. Ownership, possession or use of a ticket does not grant any right (implied or otherwise) to you to use (for any

commercial or other purpose), alter, copy or otherwise deal with the name of the Event or any part of it (or any abbreviation

or foreign language version thereof), any logo or graphic device of or relating to the Event or any of the symbols,

trademarks, logos and/or intellectual property appearing on the ticket

LIABILITY

40. The User agrees to participate at their own risk in the Event and the activities associated with the Event (including but not limited to supporting events).

41. The Promoter, the sanctioning bodies, the FIA, the FOWC and its affiliates, including Formula One Management Limited, Formula One Licensing BV, Formula One Asset Management Limited, Formula One Hospitality and Event

Services Limited, Formula Motorsport Limited, Formula One Marketing Limited, staff involved in the organization of the

Event (including officials, marshals, rescue and medical staff), competitors and drivers (such persons including where

relevant all directors, officers, employees, agents, contractors and affiliated companies), shall not be liable for any loss or

damage however caused to you or your property to the fullest extent permitted by the laws of the Event Country; this does

not exclude (i) liability for death or personal injury resulting from negligence on the part of any of the above-named parties,

or (ii) any damage caused by fraud or misrepresentation by any of the above-named parties.

42. Your personal data is collected and stored by ACI Sport in accordance with the Privacy Policy posted on www.MonzaGPF1.ticketone.it (partnershop) and TicketOne's website

([https://www.ticketone.it/en/help/data-](https://www.ticketone.it/en/help/data-protection/)

protection/) which may be updated from time to time.

43. Subject to the laws of the Event Country, you may have the right to access, correct or request deletion of your personal

data or to object to or restrict ACI Sport's processing of your personal data under certain circumstances. Any requests for

information or other questions in connection with these Terms and Conditions should be sent to ticketingF1@acisportspa.it.

44. These Terms and Conditions are subject to the application of Italian law. Any dispute between the User and the

Promoter concerning the purchase of tickets and the use of access passes, as well as the User's presence within the

Event Venue, shall be exclusively submitted to the jurisdiction of the Court of Rome, or to the court of the User's residence,

in the event that the User qualifies as a consumer pursuant to the Consumer Code, with the express exclusion of any other

potentially competent jurisdictions.

45. These Terms and Conditions are not intended to affect your legal rights as a consumer.
