### Terms and Conditions

Welcome to the website: [www.mexicogp.mx](http://www.mexicogp.mx) (hereinafter the "Website"). The following are the Terms and Conditions governing the use of the Website and owned by MAKE PRO S.A. de C.V. (hereinafter "MAKE PRO") and jointly operated by its subsidiaries and/or affiliates.

MAKE PRO manages the content and services available on the Website in accordance with the following Terms and Conditions.
