### GENERAL HOUSE RULES

#### CIRCUIT ZANDVOORT & FORMULA 1

#### HEINEKEN DUTCH GRAND PRIX

#### GENERAL

#### ARTICLE 1. LEGISLATION AND REGULATIONS

#### ARTICLE 2. OWN RISK AND LIABILITY

#### ARTICLE 3. SEARCHES, BAG CHECKS, AND IDENTIFICATION

#### ARTICLE 4. ADMISSION AND TICKETS

Dutch law and the local regulations (APV) of the municipality of Zandvoort apply on the event grounds. Visitors to events at Circuit

Zandvoort, including the F1 Heineken Dutch Grand Prix (hereafter referred to as: the event), must conduct themselves in accordance

with public order, decency, and proper behavior throughout their presence at the venue.

All visitors are required to comply with the rules and/or instructions given by the event organizers, security personnel, medical

teams, and any other parties involved in the event. Threats, assault, intimidation, discrimination, and any other form of aggression

are strictly prohibited. The use of (soft) drugs is not permitted. In cases of misconduct, disturbances, public urination, or violation

of the house rules, visitors and/or participants will be removed from the event grounds. If weapons, theft, public violence, or other

legal violations are observed, the police will be notified and a formal report will be filed.

Anyone present in the paddock, on the track, or in hospitality areas must adhere to the specific regulations applicable to that (sub)

location during the event.

Attending the event grounds is entirely at your own risk. Visitors acknowledge that auto racing, the event itself, and certain activities

related to the event can be dangerous, and they agree to be present and/or participate at their own risk.

The event organizers (and all their staff), Circuit Zandvoort (and all their staff), Formula One Management (and all their staff), the

FIA (and all their staff), suppliers (and all their staff), and the municipality of Zandvoort are not liable for any damage resulting from

attending the event, nor for the loss and/or theft of any belongings during the visit.

Any damage caused to (temporary) objects or property, or to people (visitors/staff) at the event will be recovered from the party

responsible.

The organization reserves the right to frisk visitors and inspect hand luggage, bags, and/or coats upon entry or during the event.

Visitors may also be asked to show identification. Refusal to comply may result in denial of entry or removal from the event

grounds.

Access to the enclosed event grounds is only permitted upon presentation of a valid admission ticket, along with personal

identification. The minimum age for unaccompanied attendance is 16 years. Younger visitors are only allowed entry if accompanied

by an adult with a valid admission ticket.

These house rules apply to everyone present on the premises of CM.com Circuit Zandvoort (hereinafter referred to as the "event site").

Always follow the instructions of authorized personnel, recognizable by their clothing and/or accreditation.

Access to the event grounds will be denied or revoked for individuals who:

(i) Cause any form of nuisance and/or display aggressive behavior.

(ii) Are in possession of drugs and/or visibly under the influence of drugs or excessive alcohol.

(iii) Are in possession of weapons. In such cases, the police will be notified.

(iv) Cause any kind of disturbance to the surrounding environment.

(v) Wear football club apparel, display symbols of motorcycle gangs (Outlaw Motorcycle Gangs), or wear clothing or flags

featuring nationalist symbols or expressions (national football jerseys are excepted).

All event tickets must be personalized in advance of the event. At the entrances to the enclosed event site, ticket validity will be

checked, and upon request, visitors must be able to prove that the name on the ticket matches the name of the ticket holder.

Each ticket is valid for one or more days (passe-partout & weekend tickets) and grants access to the event grounds and the

designated grandstand or zone/sector indicated on the ticket. Movement between grandstands or zones/sectors is not automatically allowed.

During regular events at Circuit Zandvoort (excluding the Dutch Grand Prix), ticket holders who leave the event grounds must check

out at the exit in order to regain entry later.

Failure to comply with these house rules entitles the organization to recover any damages from the offender(s). In case of removal

from the premises due to misconduct, the organization reserves the right to impose a fine of €350. Any damages caused will be

fully recovered in addition.

PLEASE NOTE!

During the Formula 1 Heineken Dutch Grand Prix weekend, re-entry is not allowed once you leave the event grounds.

Re-entry is

only possible for guests staying at the 538 Dutch Grand Prix Village.

The organization reserves the right to deny access or remove visitors from the venue if they fail to comply with the regulations

outlined in Article 1 or the house rules. After removal, re-entry to the venue is not permitted.

In the interest of public order and safety, the organization reserves the right to request visitors to leave the venue at any time for

security reasons. After the conclusion of the event, (re)admission will no longer be allowed.

#### ARTICLE 5. PROHIBITED ITEMS

It is not permitted to bring the following items onto the event grounds:

(i) Bags larger than A4 size and thicker than 10 cm (bags for personal medical purposes will be labeled and inspected).

(ii) Soft or hard drugs, nitrous oxide, tear gas, glassware.

(iii) Blunt, striking, or firearms, or objects that resemble weapons or are offensive in nature.

(iv) Flags with poles longer than one meter.

(v) Aerosol cans (except sunscreen, deodorant, and perfume).

(vi) Gas stoves and (disposable) barbecues.

(vii) Umbrellas (we recommend bringing ponchos instead as a precaution).

(viii) Musical instruments, audio devices, horns, or similar noise-making items.

(ix) All types of fireworks (including firecrackers, signal flares, torches, and decorative smoke).

(x) Provocative statements on clothing or banners.

(xi) Coolers (with or without contents).

(xii) (Foldable) chairs and stools.

(xiii) Any items too large to fit underneath a grandstand seat.

(xiv) Pets (except assistance dogs).

(xv) Roller skates, inline skates, skateboards, hoverboards, scooters, bicycles, (motor) scooters, electric mobility scooters, and

non-foldable wheelchairs that do not fit under a grandstand.

(xvi) Promotional material such as flyers, leaflets, and banners (unless approved by and with permission from the organization).

(xvii) Professional film, photo, or audio equipment (unless approved and accredited by the organization). A detachable lens is

the criterion for what is considered professional equipment.

(xviii) Selfie sticks and drones (both on the ground and in the air).

(xix) All other matters that, in the sole judgment of the organization and authorized personnel, may pose a danger to health, safety, and/or public order.

All confiscated items will be disposed of in designated waste containers and will not be stored. No lockers are available for

confiscated goods. Possession of the above items may result in removal from the grounds or denial of entry. Use of such items may

lead to criminal prosecution.

As with other events and festivals, bringing your own food and drinks is not permitted (except for baby food and food required for

medical reasons). In cooperation with our catering partner, we offer a varied selection of food and beverages on the event grounds.

In case of prolonged extreme heat, the organization will activate a heat protocol. This will be announced separately through the

organization's media channels.

The organization strongly advises wearing hearing protection. Earplugs and other hearing protection items are available for

purchase on-site.

Tickets for visitors with disabilities are offered separately by our partner <https://handicap.nl/toegankelijke-festivals/dutch-grand-prix/>.

PLEASE NOTE!

There are no separate disabled parking spaces available during the Formula 1 Heineken Dutch Grand Prix. Wheelchairs and foldable

electric mobility scooters are allowed, provided they can be placed underneath a grandstand. If you hold a regular ticket, please note

that the grandstands do not have designated accessible seating. This means that you and/or your companion must independently

enter the grandstand and take a regular seat.

#### ARTICLE 11. ADVERTISING AND PROMOTION

Visitors under the age of 18 are not allowed to purchase, accept, or consume alcoholic beverages. You must present identification

when requested. The organization reserves the right to refuse alcohol sales in cases of misconduct or intoxication. Smoking is not allowed on the event grounds. Smoking causes nuisance to others, is harmful to your health, addictive, and can be fatal.

It is prohibited to distribute flyers, leaflets, or any other promotional materials in or around the event grounds without prior

permission from the organization. Additionally, conducting interviews, surveys, or any (non-)commercial promotions is not allowed

without explicit approval.

To avoid confusion, no brand that could be considered promotional or for marketing purposes may be displayed by any ticket holder

at the event—unless prior explicit permission has been granted by the organization. Any associated cleanup or removal costs will

be charged to the distributor.

Within the event grounds, it is not permitted to create associations (e.g., via advertising, marketing campaigns, or promotional

activities) related to the event, the organization, FOM, Formula 1, Circuit Zandvoort, or any other commercial entity.

#### ARTICLE 12. PHOTOGRAPHY AND FILMING

During the event, photo, video, and audio recordings will be made. By entering the event grounds, visitors give their implicit consent

to the organization and third parties to record, reproduce, publish, and/or use these recordings for promotional and safety purposes.

This includes (camera) surveillance for maintaining public order and safety on the event site.

Recording with professional photo, video, or audio equipment is not allowed without prior permission and an official accreditation

issued by the organization.

The standard for professional photo or video equipment is any device with a detachable lens. Recording with smartphones and

small personal devices for private use is permitted.

#### DRONES

Video and/or photo recordings using drones are strictly prohibited for safety reasons. Circuit Zandvoort reserves the right to grant exceptional permission to a professional and certified party, provided that this is requested in writing and in a timely manner.

Without such permission and a valid license, drone use may result in fines and notification of the relevant authorities, as it constitutes a violation of safety regulations and the privacy of those involved.

#### PHOTOS AND VIDEOS

Photography is only permitted for personal purposes. Images may not be used commercially (including sale to or sharing with commercial entities, foundations, or non-profit organizations) without permission or media accreditation from Circuit Zandvoort or the Organization. The same conditions apply to video recordings.

Photography or videography using drones or other remote-controlled equipment is strictly prohibited for safety reasons.
